ORDER APPROVING INTEREXCHANGE AND NON-SWITCHED LOCAL EXCHANGE CERTIFICATES OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Legends Communications, Inc. (Legends) applied to the Public Service Commission on February 22, 1999, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440 RSMo 1994¹. Legends asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Legends is a Georgia corporation, with its principal office located at 2500 Windy Ridge Parkway, Suite 365, Atlanta, Georgia 30339.

The Commission issued a Notice of Applications for Intrastate Certificates of Service Authority and Opportunity to Intervene on March 2, 1999, directing parties wishing to intervene to file their requests by March 17, 1999. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel.

Rex Deffenderfer Enterprises, Inc. v. Public Service Commission,
776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked
permission to intervene or requested a hearing, the Commission may
grant the relief requested based on the verified application.

Legends filed a proposed tariff in conjunction with its application and filed substitute sheets on March 25, 1999, April 7, 1999, and April 13, 1999. The tariff's effective date is April 30, 1999. Legends' tariff describes the rates, rules, and regulations it intends to use, identifies Legends as a competitive company, and lists the waivers requested. Legends intends to provide interexchange telecommunications services, including 1+, 800/888/877, Directory Assistance, Operator, Debit Card, and Travel Card services.

In its memorandum filed on April 19, 1999, the Staff of the Commission (Staff) stated that Legends' proposed services are similar to existing IXC offerings. Staff recommended that the Commission grant Legends a certificate of interexchange service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on April 30, 1999.

The Commission finds that competition in the intrastate interexchange telecommunications markets is in the public interest and Legends should be a granted certificate of service authority. The Commission finds that the services Legends proposes to offer are competitive and Legends should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules

set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Legends' proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on February 22, 1999 shall be approved as amended to become effective on April 30, 1999.

IT IS THEREFORE ORDERED:

- 1. That Legends Communications, Inc. is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to the conditions of certification set out above.
- 2. That Legends Communications, Inc. is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
