## **ORDER GRANTING EXTENSION FOR FILING OF COST STUDIES**

Pursuant to the Commission's Arbitration Order issued and effective March 23, 2000, Southwestern Bell Telephone Company (SWBT), with the participation of the Commission's Staff, was directed to prepare and to file certain cost studies.

On July 7, 2000, the Commission issued an order that requested a status report regarding the cost studies. The cost studies ordered by the Commission are due September 25, 2000. On July 31, 2000, SWBT and Staff filed a report describing the status of the cost studies and requested that the filing deadline for the Loop Conditioning Cost Study, the ISDN Cost Study, and, the Cross-Connect Cost Study be extended until January 15, 2001. The report provides adequate information and a basis to support an extension. Therefore, the request by SWBT and Staff will be granted. The Commission notes that January 15, 2000, is a state holiday and therefore the cost studies will be due on January 16, 2001.

#### IT IS THEREFORE ORDERED:

1. That the filing deadline for the Cost Studies as described in this order is extended to January 16, 2001.



2. That this order shall become effective on August 22, 2000.
