- 2. That GTE Midwest Incorporated and GTE Arkansas Incorporated shall file a brief statement of the character of the business performed by each applicant as required by Commission Rule 4 CSR 240-2.060(1)(B) no later than 3:00 p.m. on December 9, 1999.
  - That this order shall become effective on December 9, 1999.
