ORDER RECOGNIZING CHANGE OF CORPORATE NAME
AND APPROVING TARIFF

On April 20, 2000, Long Distance of Michigan, Inc., d/b/a LDMI Telecommunications (LDMI), formerly known as Long Distance of Michigan, Inc., d/b/a LDMI Long Distance, filed a replacement tariff which reflects a new d/b/a. LDMI also filed a copy of the Registration of Fictitious Name. The tariff originally bore an effective date of May 20, 2000, which was extended several times, with a final effective date of October 10, 2000. In support of its filing, LDMI submitted copies of its Cancellation of Registration of Fictitious Name and the Registration of Fictitious Name from the Missouri Secretary of State's Office. On August 3, 2000, the company submitted a replacement version of its new tariff. The company submitted a third version of the proposed tariff on September 22, 2000.

The Staff of the Commission (Staff) filed a memorandum on September 28, 2000. Staff noted that the proposed tariff contains several items that are not listed in the earlier tariff, including the following:

- A new switched access Outbound Flat Rate Calling Plan.
- A new Inbound Toll-Free (8xx) Flat Rate Plan.
- A new flat per-minute rate Travel Card Service Plan.
- Discontinuing the DS-0 Dedicated Access Outbound Service, for which LDMI has no customers.
- A new section to address future promotions.

Staff states that it has no objections to these new items. Staff recommended that the name change be recognized, that the old tariff be canceled, that the revised tariff be approved.

The Commission has reviewed LDMI's filings and Staff's recommendation and finds that the change of name should be recognized. The Commission further finds that the tariff sheets, as amended, should be approved.

IT IS THEREFORE ORDERED:

1. That the change of name from Long Distance of Michigan, Inc. d/b/a LDMI Long Distance to Long Distance of Michigan, Inc. d/b/a LDMI Telecommunications, is acknowledged.

2. That the following tariff, file number 200000962, is approved to become effective on October 10, 2000:

Missouri Interexchange Telecommunications Tariff
P.S.C. MO No. 2

3. That the current Long Distance of Michigan, Inc. d/b/a LDMI Long Distance tariff P.S.C. MO No. 1 shall expire on October 10, 2000, concurrent with the effective date of the approved tariff.

4. That this order shall become effective on October 10, 2000.
