ORDER APPROVING TARIFFS IN COMPLIANCE
WITH COMMISSION ORDER

The Commission issued a Report and Order on January 23, 2001, which directed Kansas City Power & Light Company (KCPL) to file revised tariff sheets in compliance with the territorial agreement approved in the Report and Order. On March 5, 2001, KCPL filed its proposed tariff sheets (tariff file number 200100913). The tariff sheets bore an effective date of April 16, 2001.

The Staff of the Missouri Public Service Commission (Staff) reviewed the tariff sheets and filed a recommendation on March 13, 2001. Staff indicates that in its opinion, KCPL has complied with the Commission's Report and Order of January 23, 2001. Staff recommends that the Commission approve KCPL's tariff sheets, to become effective on April 16, 2001.

The Commission has reviewed the tariff sheets and Staff's recommendation, and finds that the tariff sheets conform to the Commission's order of January 23, 2001, and should be approved to become effective on April 16, 2001.

IT IS THEREFORE ORDERED:

1. That the tariffs filed by Kansas City Power & Light Company on March 5, 2001, and assigned tariff number 200100913, are approved to become effective on April 16, 2001. The tariffs approved are:
