ORDER ACKNOWLEDGING CHANGE OF NAME  
AND APPROVING TARIFF

On February 1, 1996, National Accounts, Inc. d/b/a Lang EDP Corp. (National Accounts) filed a letter with the Commission indicating that its name had changed from National Accounts, Inc. d/b/a Lang EDP Corp. to National Accounts, Inc. National Accounts also included with their letter a certified copy of the amended certificate of authority of a foreign corporation issued by the Missouri Secretary of State, which reflected the name change, and an adoption notice wherein National Accounts formally adopts the tariffs of National Accounts, Inc. d/b/a Lang EDP Corp.

On February 23, 1996, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum stating that Staff had no objections to the filing. Staff recommends that the Commission issue an order to amend the certificate of service authority issued to National Accounts, Inc. d/b/a Lang EDP Corp. to reflect the name change, and to approve the adoption notice effective March 4, 1996. Staff added that it is unaware of any other filing which affects or which would be affected by this proposal.

The Commission has reviewed the official case file and Staff's recommendation, and is of the opinion that there is no reason to object to the change of the company's name from National Accounts, Inc. d/b/a Lang

EDP Corp. to National Accounts, Inc., as the change in name is slight and is unlikely to result in customer confusion. Likewise, the Commission finds that the adoption of the company's existing tariffs by the company under its new name is just and reasonable. The Commission will therefore approve the adoption notice effective March 4, 1996.

**IT IS THEREFORE ORDERED:**

1. That the Commission hereby acknowledges the corporate change in the name of the company from National Accounts, Inc. d/b/a Lang EDP Corp. to National Accounts, Inc.

2. That the certificate of service authority previously issued to National Accounts, Inc. d/b/a Lang EDP Corp. in Case No. TA-94-157 is hereby amended to reflect the change in corporate name from National Accounts, Inc. d/b/a Lang EDP Corp. to National Accounts, Inc.

3. That the following tariff sheet submitted by National Accounts, Inc. on February 1, 1996 is hereby approved to become effective March 4, 1996:

4. That this Order shall become effective on March 4, 1996.
