ORDER AND NOTICE

On December 15, 1999, UtiliCorp United Inc. (UtiliCorp) and The Empire District Electric Company (Empire) filed a joint application with the Commission for authority to merge Empire with and into UtiliCorp. Proper parties should be given notice and an opportunity to intervene in this matter. The Records Department of the Commission shall send a copy of this order to the mayors of all municipalities and county commissions located within the service areas of UtiliCorp and Empire. The Information Officer of the Commission shall send notice of this application to the members of the General Assembly who represent each county located within the service areas of UtiliCorp and Empire, and to the newspapers that serve each county within the service areas of UtiliCorp and Empire, as listed in the newspaper directory of the current Official Manual of the State of Missouri. In addition, the Records Department of the Commission shall send notice to all the electric



companies regulated by the Commission, to all gas companies regulated by the Commission, and to all water companies regulated by the Commission.

Proper persons wishing to intervene shall file an application to intervene with the Secretary of the Missouri Public Service Commission. Copies of the application to intervene should be sent to the parties listed below.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary and that the Applicant may submit its evidence in support of the application by verified statement. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989).

IT IS THEREFORE ORDERED:

- 1. That the Information Office and the Records Department of the Missouri Public Service Commission shall provide notice as set out herein.
