ORDER AND NOTICE

Frontier Telemanagement, Inc. (Frontier) filed an application on October 14, 1997, for certificates of service authority to provide basic local and local exchange telecommunications service in the State of Missouri under 4 CSR 240-2.060(4). Specifically, Frontier wishes to provide resold services in all the exchanges currently served by Southwestern Bell Telephone Company. Frontier asked to be classified as a competitive company and receive a lesser degree of regulation as permitted by Sections 392.361 and 392.420, RSMo. Frontier requested a temporary waiver of 4 CSR 240-2.060(4)(H) that requires an applicant to file a tariff simultaneously with its application, on the grounds that it is impossible for Frontier to prepare a tariff until it has executed an interconnection agreement with SWBT, and the agreement has been approved by the Commission. Finally, Frontier requested waiver of the following statutes and Commission rules:
