ORDER APPROVING ACTUAL COST ADJUSTMENT AND CLOSING DOCKET

On May 1, 1995, the Staff of the Commission (Staff) filed a memorandum concerning Greeley Gas Company's (Greeley) 1993-1994 Actual Cost Adjustment (ACA) filing. Staff conducted an audit of Greeley's billed revenues and actual gas costs for the period of June, 1993 to May, 1994. Staff recommended that:

- (1) the ACA balance remain unchanged at \$24,644 over-recovery;
- (2) Greeley maintain separate transportation schedules (TA0544, TA0545, and TA0546) for the purpose of allocating transportation costs to the service areas directly affected;
- (3) Greeley maintain a monthly summary sheet of all transactions affecting the monthly Rangeline, North Whelan, or other gas supplier invoices;
- (4) Greeley develop a formalized Gas Procurement Plan which includes a formalized bidding process, to be effective August 1, 1995; and
- (5) Greeley develop a design peak day analysis for its Kansas and Missouri divisions combined including an estimated peak day requirement for the Bourbon County, Kansas delivery point, to be effective August 1, 1995.

On June 15, 1995, Greeley filed a response to Staff's memorandum.

Greeley agreed with Staff's recommendations but requested one change. Greefey requested that the August 1, 1995 effective date within Staff's fourth and fifth recommendations be changed to October 1, 1995.

On July 3, 1995, Staff replied to Greeley's response. Staff agreed to Greeley's requested change. Staff also requested that the Commission adopt its recommendations and close this docket.

Upon review of Staff's recommendations, Greeley's response, and Staff's reply, the Commission determines that Staff's recommendations should be adopted. The Commission also determines that Greeley's 1993-1994 ACA rates should be approved on a permanent basis and that this docket should be closed.

IT IS THEREFORE ORDERED:

- 1. That the Actual Cost Adjustment rates filed in this case by Greeley Gas Company for the period 1993-1994 are hereby approved on a permanent basis.
- 2. That the recommendations filed in this case on May 1, 1995, by the Staff of the Commission, as modified in the response filed in this case on June 15, 1995 by Greeley Gas Company, are hereby approved and adopted.
 - 3. That Case No. GR-94-129 is hereby closed.
 - 4. That this Order shall become effective on July 25, 1995.
