

ORDER APPROVING TARIFFS FILED IN COMPLIANCE
WITH COMMISSION ORDER

The Commission approved a water service territorial agreement between Missouri-American Water Company (Company) and the Public Water Supply District No. 2 of St. Charles County, Missouri (District) on May 15, 2001. As part of the Report and Order, the Commission directed the Company to file revised tariff sheets in compliance with the approved territorial agreement. On June 25, 2001, the Company filed its proposed tariff sheets (tariff file number 200101217). The tariff sheets bore an effective date of July 25, 2001.

The Staff of the Missouri Public Service Commission (Staff) reviewed the tariff sheets and filed a recommendation on July 16, 2001. Staff recommends that the Commission approve the Company's tariff sheets to become effective on July 25, 2001.

The Commission has reviewed the tariff sheets and Staff's recommendation, and finds that the tariff sheets conform to the Commission's order of May 15, 2001, and should be approved to become effective on July 25, 2001.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by Missouri-American Water Company on June 25, 2001, and assigned tariff number 200101217, are approved to become effective on July 25, 2001. The tariff sheets approved are:
