ORDER DIRECTING APPLICANT TO FILE STATUS REPORT

On March 29, 2000, Ozark Water and Wastewater Management Co., Inc. filed an application for authority to transfer its franchise, treatment plant, and substantially all its assets to a non-profit sewer corporation. After numerous requests for delay of the established procedural schedule, the Commission, on August 14, 2001, canceled the procedural schedule to permit Ozark Water and Wastewater more time to negotiate a possible settlement. There has been no activity in this case since August 14, 2001.

So that the Commission may learn whether it will need to take any further action in this case, the Commission will direct Ozark Water and Wastewater to file a status report.

IT IS THEREFORE ORDERED:

1. That no later than May 3, 2002, Ozark Water and Wastewater Management Co., Inc. shall file a report advising the Commission as to the status of its application for authority to sell its franchise, treatment plant, and substantially all of its assets to Northern Christian County Regional Wastewater Facility, Inc.



2. That this order shall become effective on April 12, 2002.
