ORDER GRANTING CERTIFICATE AS AN ENERGY SELLER

On October 16, 1998, Woodward Marketing, L.L.C. (Woodward) filed an application with the Commission, pursuant to 4 CSR 240-45.010, requesting certification as a seller of energy services in Missouri. 4 CSR 240-45.010 provides that an energy seller seeking certification from the Commission shall file an agreement containing:

- (A) Its agreement to pay all applicable business license taxes, or its proportionate share of the franchise fee or payment in lieu of taxes in each political subdivision in which it sells energy;
- (B) A statement that it waives its right to challenge the validity of the agreement;
- (C) A statement that it waives its right to the refund of any amounts paid pursuant to the agreement; and
- (D) Its agreement to make its records available to the commission and the political subdivision with the right to audit the records.
- 4 CSR 240-45.010 also provides that an energy seller seeking certification shall file its name, address, telephone number, and the name of a person to contact regarding certification, location of records

and business operations in Missouri, as well as a list of each political subdivision in which it sells energy.

On October 2, the Staff of the Missouri Public Service Commission (Staff) filed its Memorandum in which it recommends that the Commission approve Woodward's application for certification. Staff states that it reviewed the application and concludes that it meets all the requirements of 4 CSR 240-45.010.

The Commission finds that Woodward has complied with 4 CSR 240-45.010 and should be granted a certificate as an energy seller. The Commission will direct its Records Department to send a copy of this order to all the political subdivisions in which Woodward has applied for, and is herein granted, certification as an energy seller.

IT IS THEREFORE ORDERED:

- That Woodward Marketing, L.L.C. is granted a certificate as an energy seller pursuant to 4 CSR 240-45.010.
- That the Records Department of the Missouri Public Service 2. Commission shall provide notice as set out herein.
 - That this order shall become effective on November 27, 1998. 3.
