ORDER ESTABLISHING TIME IN WHICH TO RESPOND TO MOTION TO ESTABLISH HEARING DATE

On October 12, 2000, UtiliCorp United Inc. (UtiliCorp) and The Empire District Electric Company (Empire) filed a motion asking the Commission to schedule a date to hear evidence regarding the issues raised by a group of retired employees of The Empire District Electric Company (Empire retirees). The Commission did not previously hear evidence on those issues because UtiliCorp, Empire and the Empire retirees announced at the hearing that they had reached an agreement in principle to resolve the areas of dispute between them. UtiliCorp reports that the parties have continued to negotiate and expect to be able to work out the final details of their agreement. However, they do not yet have a final, signed agreement. Because they wish to ensure that the Commission is able to issue a decision in this case as soon as possible, UtiliCorp and Empire ask that the Commission schedule a hearing now so that the remaining issues may be heard, if they are not resolved by agreement of the parties. UtiliCorp and Empire's motion indicates that counsel for UtiliCorp and Empire has discussed this motion with counsel for the Empire retirees and reports that the Empire retirees do not object to the relief requested.

So that the Commission may promptly consider their request for the establishment of a hearing date, UtiliCorp and Empire request that the Commission shorten the time for filing responses to their motion to October 16. The Commission does wish to act quickly on UtiliCorp and Empire's motion. However, allowing only two business days to respond to the motion is not sufficient. The Commission will allow the other parties until October 18 to respond.

IT IS THEREFORE ORDERED:

- 1. That any party wishing to respond to the Motion to Establish Hearing Date filed by UtiliCorp United Inc. and The Empire District Electric Company shall do so on or before October 18, 2000.
 - 2. That this order shall become effective on October 18, 2000.
