ORDER REGARDING LATE FILED EXHIBITS AND BRIEFING SCHEDULE

During the course of the evidentiary hearing in this matter (specifically on October 27, as recorded at pages 373-379 of the transcript), the Commission reserved Exhibits 36 through 39 for information to be provided by the Osage Beach Fire Protection District (the District). The Commission also (on October 28, as recorded at pages 779-780 of the transcript) reserved Exhibit 45 for information to be provided by the Staff. Although some information that may pertain to some of these exhibits was filed by Osage Water Company on November 12, neither of the parties responsible for the filing of these exhibits has done so. Because these exhibits have not yet been filed, the briefing schedule discussed at the end of the hearing may no longer be

appropriate. The Commission will direct Staff and the District to file their late-filed exhibits and direct the parties to submit a proposed briefing schedule.

IT IS THEREFORE ORDERED:

1. That the Osage Beach Fire Protection District shall submit nine copies of Exhibits 36 through 39 to the Regulatory Law Judge, and deliver a copy to each of the parties, no later than December 1, 1998.

2. That the Staff of the Commission shall submit nine copies of Exhibit 45 to the Regulatory Law Judge, and deliver a copy to each of the parties, no later than December 1, 1998.

3. That any objections to the admission into the record of these late-filed exhibits shall be filed no later than December 10, 1998.

4. That the parties shall submit a proposed briefing schedule no later than December 1, 1998.

5. That this order shall become effective on December 1, 1998.
