ORDER SETTING ADDITIONAL LOCAL PUBLIC HEARING

On January 13, 1998, the Commission issued its Order Setting Local Public Hearings, which established times and locations for one local public hearing in St. Charles County, two local public hearings in St. Louis County, and one local public hearing in St. Louis City. The Commission has determined that the public interest would be served by an additional local public hearing, and that the hearing should be held in Jefferson County.

The Commission's Information Officer should send notice of the hearings to the publisher of each newspaper located in the 314 NPA, and to members of the Missouri General Assembly representing customers in the 314 NPA. In addition, the Information Officer should provide similar notice to any radio and television stations located within the 314 NPA. The Commission's Records Department should serve a copy of this order on the County Commission of each county and the mayor of each municipality within the 314 NPA.

IT IS THEREFORE ORDERED:

1. That one local public hearing in addition to the four local public hearings that were set by the Commission in its January 13, 1998, order is set for the following time and location:
