ORDER GRANTING MOTION TO MODIFY PROCEDURAL SCHEDULE AND TO CORRECT PREVIOUS PROCEDURAL ORDER

On December 31, 1997, Birch Telecom of Missouri, Inc. (Birch) filed a petition with the Commission to arbitrate the terms of interconnection between Birch and Southwestern Bell Telephone Company (SWBT) pursuant to Section 252(b) of the Telecommunications Act of 1996 (the Act). Because of the time constraints imposed by the Act, the Commission issued an Order Adopting Procedural Schedule and Protective Order (Procedural Order) on January 27, 1998.

On February 9, Birch moved to modify certain elements of the procedural schedule. Specifically, Birch's proposal would extend the filing deadline for all of the parties' direct testimony from February 13 to February 18, extend the deadline for filing all of the parties' rebuttal testimony from February 27 to March 4, and reschedule the prehearing conference to March 6. Additionally, Birch's attorney represented to the Commission that SWBT does not oppose the proposed modifications to the current procedural schedule.

The Commission finds Birch's request to be reasonable and will not prejudice any party. Therefore, the Commission will grant Birch's motion and modify the procedural schedule as proposed.

The Procedural Order also erroneously indicated that the Commission Staff (Staff) would be responsible for preparing and filing the hearing memorandum. The parties themselves will be responsible for preparing and filing the hearing memorandum in accordance with the procedural schedule.

IT IS THEREFORE ORDERED:

- 1. That the Motion to Modify Procedural Schedule filed by Birch Telecom of Missouri, Inc., on February 9, 1998, is granted.
- 2. That the following modified procedural schedule is adopted for this proceeding:

3. That Birch Telecom of Missouri, Inc., and Southwestern Bell Telephone Company shall jointly file a hearing memorandum in accordance with the modified procedural schedule.

4. That this order shall be effective on February 11, 1998.
