ORDER DIRECTING STAFF TO FILE RECOMMENDATION OR STATUS REPORT

On April 14, 2000, World Access, Inc., (WAXS) and Communications TeleSystems International d/b/a WORLDxCHANGE Communications (CTI) filed a joint application asking that the Commission approve a transaction whereby CTI will merge with and into WorldxChange Communications, Inc., a wholly owned subsidiary of WAXS.

Despite the passage of five months since the filing of the application, the Staff of the Commission has not filed any recommendations regarding the application. The Commission would like to move this case forward. Therefore, the Staff of the Commission will be directed to file either a recommendation or a case status report informing the Commission of when it will be able to file its recommendation regarding the application.

IT IS THEREFORE ORDERED:

1. That no later than October 11, 2000, the Staff of the Public Service Commission shall file either a recommendation or a report advising the Commission as to the status of its recommendation regarding the Joint Application filed by World Access, Inc. and Communications TeleSystems International, d/b/a WORLDxCHANGE Communications.

2. That this order shall become effective on October 2, 2000.
