**ORDER APPROVING TARIFF AND CANCELING CERTIFICATE**

On October 17, 2000, the Commission issued an order approving a transaction whereby Communications TeleSystems International d/b/a WORLDxCHANGE Communications (CTI) was merged with and into WorldxChange Communications, Inc. (WxC), a wholly owned subsidiary of World Access, Inc. The order provided that the Commission's approval of the transaction was conditioned upon WxC having its own tariff then in effect or upon its immediate adoption of the tariff of CTI. Furthermore, the order directed that, within ten days following the completion of the authorized transaction, the surviving company, WxC, was to file a pleading notifying the Commission that the certificate and tariff (if not adopted by WxC) of CTI might then be canceled.

On January 23, 2001, the Commission issued an order directing WxC to file a pleading by February 13 informing the Commission of the status of the transaction authorized in the Commission's October 17, 2000, order. In response, on February 6, WxC filed a pleading indicating that the merger transaction has been completed and asking that CTI's Certificate of Authority to Provide Interexchange Telecommunications Services be canceled. Along with that pleading, WxC filed a tariff whereby

it adopts the tariff of CTI. WxC's tariff sheets initially carried an effective date of March 8, 2001. On February 9, WxC filed substitute tariff sheets that extended the effective date of the tariff sheets until March 12, 2001.

On February 15, the Staff of the Commission (Staff) filed a Recommendation and Memorandum in which Staff recommends that the Commission cancel CTI's Certificate of Authority to Provide Interexchange Telecommunications Services and approve WxC's adoption of CTI's tariff.

Having considered the matter, the Commission concludes that CTI's Certificate of Authority to Provide Interexchange Telecommunications Services should be canceled and that WxC's adoption of CTI's tariff should be approved.

**IT IS THEREFORE ORDERED:**

1. That Communications TeleSystems International, d/b/a WORLDxCHANGE Communications' Certificate of Authority to Provide Interexchange Telecommunications Services is canceled.


2. That the tariffs filed by WorldxChange Communications, Inc. on February 6, 2001, and assigned Tariff No. 200100808, is approved, as amended, to become effective on March 12, 2001. The tariff approved is:
