# ORDER DENYING THE OFFICE OF THE PUBLIC COUNSEL'S MOTION FOR CORRECTION AND CLARIFICATION OF THE ORDER DELAYING IMPLEMENTATION OF 314 NPA AND 816 NPA OVERLAY RELIEF PLANS

#### Syllabus:

This order denies the Office of the Public Counsel's motion for correction and clarification filed on October 2, 2001.

#### Discussion and Decision:

The Public Counsel filed its October 2, 2001 motion for correction and clarification saying that the Commission had incorrectly stated Public Counsel's position at page 3 of the September 25, 2001 order, where the Commission found that: "In filing in support of the Committee's recommendation, the Public Counsel effectively abandoned a previous position advocating a trigger for implementing NPA relief based upon a set number of codes for assignment."

In this proceeding the Public Counsel has advocated that implementation of area code relief for the 314 NPA be delayed until 90 central office codes remained and



on July 23, 2001, the Public Counsel filed its Motion to Further Postpone Implementation of Dates for the 314 NPA and 816 NPA Relief Plans "in accordance with Public Counsel's original suggestions." (Page 9 of the motion to postpone implementation dates.)

On August 31, 2001, the Technical Implementation Subcommittee filed its report and recommended, "An indefinite delay in both the 314 and 816 NPA overlay relief plans." On August 31, 2001, the Public Counsel filed Suggestions in Support of the Technical Implementation Subcommittee Report to the Commission on the Extension to the Implementation Dates for the 314 NPA and the 816 NPA Relief Plan urging the Commission to "approve the recommendations of the Technical Implementation Subcommittee Report to the Commission on the Extension to the Implementation Dates for 314 NPA and 816 NPA Relief Plans filed on August 31, 2001."

The Commission accepted the subcommittee's recommendation and ordered an indefinite suspension of the overlay relief plans. The information presented to the Commission showed that the rate of code assignments had slowed dramatically from the time that the relief plans were first ordered.

Public Counsel endorsed the recommendation for an indefinite delay which is contrary to its original position advocating "90" and "100" code trigger points. Public Counsel's recommendation for "90" and "100" code trigger points is not appropriate in

light of the present rate of code assignments because these trigger points would require the expense and burden of code relief prior to the time relief is actually needed.

The Commission's September 25, 2001 Order Delaying Implementation of the 314 NPA and 816 NPA Overlay Relief Plans and Dismissing a Party expressly authorizes any party, including the Public Counsel, to move for the Commission's action and for appropriate relief when the facts and circumstances warrant action. The Public Counsel is free to advocate implementation, further delay or any sort of trigger threshold it deems appropriate when, and if, the Commission is asked to take this matter up again.

#### IT IS THEREFORE ORDERED:

- That the Office of the Public Counsel's Motion for Correction and Clarification of the Order Delaying Implementation of 314 NPA and 816 NPA Overlay Relief Plans filed on October 2, 2001, is denied.
  - 2. That this order shall become effective on November 4, 2001.
