EVIDENCE OF SETTLEMENT AND REQUEST TO DISMISS


Comes now Union Electric Company d/b/a AmerenUE and for its Request to Dismiss states as follows:

## COMPREHENSIVE SETTLEMENT, DISCHARGE AND RELEASE

THIS COMPREHENSIVE SETTLEMENT, DISCHARGE AND RELEASE (hereinafter this "Release") is made and entered into as of this 13 day of June, 2001, by  
DARLA JARMAN

(hereinafter "Settling Party" in favor of Union Electric Company, a Missouri corporation, its officers, directors, employees, agents, shareholders, affiliates, predecessors, successors in interest, and assigns (Union Electric Company and such related persons, associations and entities are hereinafter collectively referred to as "Released Parties").

WHEREAS, Settling Party filed a claim against one or more of Released Parties before the Missouri Public Service Commission as Complaint No. EC-2001-471 (hereinafter the "Complaint"); and

WHEREAS, Settling Party alleged in the Complaint, *inter alia*, to have suffered damages and/or loss by reason of the matters set out in her claim; and

WHEREAS, Settling Party has reached an agreement to settle any and all claims, demands, suits, and causes of action and any and all related matters for \$660.00;

NOW THEREFORE, the parties hereto agree as follows:

1. Settling Party hereby acknowledges receipt of \$660.00 in hand paid by one or more of Released Parties in full and complete satisfaction, settlement, discharge and release of Released Parties from and against any and all claims, demands, suits, causes of action (including, without limitation, claims for personal injury, bodily injury, death, property damage, unjust enrichment, environmental liability and pollution liability), attorney's fees, and liability arising out or relating to, directly or indirectly, the facts, circumstances or events alleged or which might have been alleged in the Complaint, whether separately or in combination with other facts, circumstances or events and, without limitation, regardless of whether:

- (a) known or unknown,
- (b) liquidated or unliquidated,
- (c) derivative or not,
- (d) continuing or not,
- (e) disputed or otherwise

(hereinafter all such claims, demands, suits and causes of action are collectively referred to as the "Claim(s)"). Settling Party hereby fully releases and discharges Released Parties from the Claim(s).


2. Settling Party further acknowledges that she has completely read and fully understands the terms of this Release. In signing this document, Settling Party is relying upon

her own judgment, belief and knowledge. To the extent the Settling Party deemed it necessary, the Settling Party has had the opportunity to consult with an attorney of the Settling Party's own choosing in signing this document.

3. Settling Party agrees to the immediate dismissal of the Complaint as filed before the Missouri Public Service Commission.

4. This Release shall be binding upon and inure to the benefit of the parties hereto and their personal or legal representatives, heirs, legatees, transferees, successors in interest, and assigns.

5. Settling Party understands and agrees that this Release represents a compromise settlement of a doubtful and disputed claim, and that Released Parties expressly deny liability to Settling Party. Settling Party further acknowledges and agrees that she is voluntarily signing and accepting this Release for the express purpose of making a full and final compromise settlement.
