## ORDER CANCELING PRIVATE PAY TELEPHONE CERTIFICATES

Issue Date: October 17, 2005 Effective Date: October 27, 2005

This order cancels the private pay telephone certificates of David E. Obernier, Robert A. Thebeau, Douglas Ross, Jeff D. Baygents, Kyle B. Cline, Russell E. Hardt, Charles Glenn Clark d/b/a Clark's Communications System, Edmund D. Jones d/b/a Vagabond Publishing Company, Kent Gilmore d/b/a Lourell's, Bart D. Booth, and James Callahan d/b/a Callahan Enterprise & Distribution (hereinafter collectively referred to as "Providers").

On July 20, 2005, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificates to provide pay telephone service of the Providers be canceled. Staff alleges that it is unable to contact the Providers through either a mailing address or a telephone number. Staff also states that each of the 2006 statement of revenue forms mailed to the Providers on January 14, 2005, was returned as undeliverable.

Furthermore, Staff argues that by failing to keep the Commission informed of a current address, the Providers have each denied the Commission the ability to supervise their telecommunications operations and services<sup>1</sup> and have denied the Commission access to their books and records.<sup>2</sup>

Section 392.410, RSMo 2000, gives the Commission authority over the granting of certificates of service authority to provide telecommunications services. The Commission has reviewed the motion and finds that the private payphone certificates granted to each of the Providers shall be canceled.

## IT IS THEREFORE ORDERED:

- That the private payphone certificate granted to David E. Obernier in Case
  No. TA-97-156 is canceled.
- 2. That the private payphone certificate granted to Robert A. Thebeau in Case No. TA-98-553 is canceled.
- 3. That the private payphone certificate granted to Douglas Ross in Case No. TA-94-376 is canceled.
- 4. That the private payphone certificate granted to Jeff D. Baygents in Case No. TA-96-457 is canceled.
- 5. That the private payphone certificate granted to Kyle B. Cline in Case No. PA-2003-0040 is canceled.
- 6. That the private payphone certificate granted to Russell E. Hardt in Case No. TA-98-381 is canceled.
