NOTICE OF DISMISSAL SOLELY WITH RESPECT TO TELETRUST, INC.

COMES NOW the Staff of the Missouri Public Service Commission (Staff), and moves that the Commission dismiss Teletrust, Inc., from this matter. Staff further withdraws its request to cancel the certificate of Teletrust, Inc. In support of its dismissal of Teletrust, Inc. and the withdrawal of its request to cancel the certificate, Staff respectfully states:

1. In its *Motion to Open Case and Cancel Certificates of Service Authority*, Staff alleged that Teletrust was dissolved at the Missouri Secretary of State's office and had not submitted a statement of revenue to the Commission for at least the past two years. Staff further noted that mail had not been returned from the address provided by Teletrust, Inc.

2. Staff obtained service of its *Motion* upon Teletrust, Inc.'s Missouri registered agent. That agent forwarded Staff's *Motion* to Teletrust, Inc. at its current address. Upon receiving the *Motion*, a Teletrust, Inc. representative contacted the undersigned attorney and indicated that the company had moved several times since it had the address that was on file with the Commission.

3. The Teletrust, Inc. representative has subsequently provided the Commission with current contact information and has also completed and submitted a statement of revenue. The

company's representative also indicated that the company would proceed to correct the delinquencies with the Missouri Secretary of State as well.

4. Based on the above information, the company is continuing to provide payphone service and its certificate should not be cancelled. Further, the company has now complied with submitting its statement of revenue and the Commission now has current contact information.

5. The Commission's rule at 4 CSR 240-2.116 permits an applicant to voluntarily dismiss an application without an order of the Commission if no testimony has been filed or oral evidence has been provided. As no testimony or oral evidence has been submitted in this case, the Staff dismisses Teletrust, Inc. from this proceeding.

6. This dismissal in no way affects the allegations regarding CAI of Texas, Inc., Mannacom Telecommunications, Inc., and Northwestern Communications, Inc. Staff requests that this case remain open and that the Commission proceed to cancel those certificates of service authority.

WHEREFORE, the Staff recommends the Commission cancel the certificates of service authority of CAI of Texas, Inc., Mannacom Telecommunications, Inc., and Northwestern Communications, Inc. to provide private pay telephone service, and dismisses Teletrust, Inc. from this case.
