ORDER APPROVING TARIFF
PURSUANT TO COMMISSION ORDER

On April 11, 2000, the Missouri Public Service Commission (Commission) ordered, *inter alia*, that RDE Water Company (RDE) should file a revised tariff in compliance with the unanimous stipulation and agreement filed on March 24, 2000, and the amendment to the unanimous stipulation and agreement filed on April 5, 2000.

On April 24, 2000, RDE filed its revised tariff which increased its rates in compliance with the Commission's order of April 11, 2000.

On April 25, 2000, the Staff of the Commission (Staff) filed its recommendation. Staff stated that it had reviewed the filing by RDE and recommended the approval of the changes to RDE's tariff sheets per the Staff memorandum attached to Staff's pleading as Appendix A. In Appendix A, Staff stated that the proposed tariff revisions were in compliance with the Commission's order of April 11, 2000. Staff stated that it agreed with RDE's request for expedited approval, so as to avoid further delay in implementing the rate increases. Staff pointed out that not only has no opposition to the rate increase ever

been voiced, but all parties have also stipulated to all the proposed rate and language changes. Staff recommended the tariffs become effective on May 1, 2000.

The Commission finds that good cause exists to approve the tariff on less than thirty (30) days' notice, that RDE's tariff filing is reasonable, in the public interest, in compliance with the April 11, 2000 order of the Commission, and that it should be approved.

IT IS THEREFORE ORDERED:
