**ORDER APPROVING TARIFF SHEETS FILED
IN COMPLIANCE WITH COMMISSION'S ORDER**

On July 21, 1998, the Commission issued an Order Granting Variance that required Associated Natural Gas Company (ANG) to file, by August 31, tariff sheet changes to reflect a three-year variance from 4 CSR 240-10.030, regarding the testing of gas meters. On August 5, ANG filed the tariff sheets required by the Commission's order. On August 21, ANG filed tariff sheets to correct clerical errors in the original tariff sheets filed.

On August 25, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum to the official case file. Staff states that it has reviewed the tariff sheets and is of the opinion that they comply with the Commission's order.

The Commission has reviewed ANG's tariff filing and the Staff's memorandum. Based on the review of ANG's tariff filing and Staff's memorandum, the Commission finds that the tariff sheets should be approved for service rendered on and after September 8, 1998.

IT IS THEREFORE ORDERED:

1. That Tariff No. 9900098, submitted in File No. GO-98-567, by Associated Natural Gas Company on August 5, 1998, and substituted on August 20, is hereby approved for service to be rendered on or after September 8, 1998:

2. That this order shall become effective on September 11, 1998.
