**ORDER APPROVING TARIFFS FILED**  
**IN COMPLIANCE WITH COMMISSION DECISION**

On April 13, 1999, the Commission issued its order denying intervention requested by GST Steel Company and the City of Kansas City, Missouri. In addition, the Commission approved the stipulation and agreement that had been filed on January 26, 1999 by the Staff of the Missouri Public Service Commission (Staff), the Office of the Public Counsel, and Kansas City Power & Light Company (KCPL). On April 22, 1999, KCPL filed the tariff sheets as required. The tariff sheets filed reflect the approved 3.2 percent reduction in tariff rates for certain customers. KCPL filed its suggestions in support of its tariff filing on April 23.

On May 27, 1999, Staff filed a memorandum recommending that the Commission approve the proposed tariff sheets as filed to become effective on August 1, 1999. Staff noted that KCPL had proposed to implement the refund and approve revenue reduction effective August 1, 1999, and to increase the refund percentage from 3.2 to 3.235 percent to reflect the addition of interest at 6 percent annual rate from April 23, 1999, through the last billings prior to August 1, 1999.

Staff stated that it had reviewed KCPL's proposal and finds it acceptable. In addition, Staff stated that it had reviewed the tariff sheets and is of the opinion that the tariff sheets comply with the Commission's order.

The Commission has reviewed KCPL's tariff filing and Staff's memorandum. The Commission finds that the tariff sheets filed should be approved for service rendered on or after August 1, 1999.

**IT IS THEREFORE ORDERED:**

1. That Tariff File No. 9900824, submitted in Case No. ER-99-313 by Kansas City Power & Light Company, is hereby approved for service to be rendered on or after August 1, 1999:
