ORDER CANCELING CERTIFICATES OF SERVICE AUTHORITY

Issue Date: December 15, 2005

Effective Date: December 25, 2005

On December 1, 2005, the Staff of the Missouri Public Service Commission filed a motion to cancel the certificates of service authority to provide private pay telephone service of the above-captioned parties. Soon thereafter, Staff filed a motion to dismiss two of the above named parties: Douglas Ross and Jeffry Faulkner d/b/a Mister Jeff's Hair Center. Staff states that Douglas Ross' certificate has already been cancelled. With regard to Jeffry Faulkner, Staff states that upon receiving Staff's motion, Mr. Faulkner informed Staff that he wished to keep his certificate.

In support of its motion to cancel the certificates of the remaining parties, Staff stated that none of the providers listed returned the Commission's Statement of Revenue form for the FY-2006 Assessment. Staff stated that it attempted to contact the providers. Those that were contacted confirmed that that they had no objection to their certificates being canceled. The

remaining providers either did not return Staff's telephone calls or the telephone numbers have been disconnected or reassigned. Staff also submitted, as Appendix A, the case numbers in which the providers were granted the perspective certificates.

Commission rule 4 CSR 240-2.080(15) requires that responsive pleadings be filed within ten days. Staff filed its motion on December 1. No party has filed a response.

Section 392.410, RSMo 2000, provides that "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission has reviewed Staff's motion and finding it reasonable, will grant the requested relief.

IT IS THEREFORE ORDERED:

1.
