ORDER GRANTING REQUEST TO BE EXCUSED FROM THE HEARING

Most of the issues in this case have been resolved by a stipulation and agreement that the Commission has approved. One issue remains for decision, and a hearing regarding that issue will take place on October 31, 2018. Only Ameren Missouri, Staff, and Public Counsel have witnesses scheduled to testify at the hearing. On October 25, the Missouri Department of Economic Development – Division of Energy filed a request to be excused from participating in the hearing, indicating it waives its right to make an opening statement and to cross-examine witnesses.

The Commission will grant Division of Energy’s request. The Commission notes the Missouri Department of Conservation, Missouri Industrial Energy Consumers, the Natural Resources Defense Council, Sierra Club, and Renew Missouri are also parties that will not have a witness at the hearing. Those parties are also excused from the hearing if they do not wish to participate.

THE COMMISSION ORDERS THAT:

1. The Missouri Department of Economic Development – Division of Energy’s request to be excused from the evidentiary hearing is granted.

2. Any other party that does not have a witness and does not wish to participate is also excused from the evidentiary hearing.

3. This order shall be effective when issued.
