**MOTION TO EXTEND DEADLINE  
FOR PROPOSING PROCEDURAL SCHEDULE**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company), and for its Motion to Extend Deadline for Proposing Procedural Schedule, states as follows:

1. On November 27, 2006, Eva Owen of 2711 Twin Valley Road, Troy, Missouri 63379 initiated this proceeding by filing a Complaint against AmerenUE.

2. On January 8, 2007, the Missouri Public Service Commission (Commission) issued its Order Setting Prehearing Conference and Directing Filing of Procedural Schedule. This order scheduled a prehearing conference for February 8, 2007 and required the parties to file a proposed procedural schedule by February 16, 2007.

3. The prehearing conference was held as scheduled. The parties discussed an appropriate hearing date. However, Ms. Owen indicated to all parties at the prehearing conference and then again today to counsel for AmerenUE that she desires to hire an attorney to assist her in this matter. Consequently, there is not yet agreement on specific dates for the procedural schedule.

4. In order to allow Ms. Owen additional time, AmerenUE requests the Commission grant an extension of time for the parties to submit a proposed procedural

schedule. AmerenUE requests that the Commission order a proposed procedural schedule be submitted by the parties no later than February 28, 2007. AmerenUE has discussed this proposal with Ms. Owen and she has indicated that she does not oppose the extension.

WHEREFORE, AmerenUE respectfully requests that the Commission issue an order granting the parties an extension until February 28, 2007, to propose a procedural schedule in this matter.
