On January 28, 2022, Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, Renew Missouri Advocates d/b/a Renew Missouri, and the Office of the Public Counsel (collectively the "Signatories") filed a joint motion in both of the above-captioned files. The Signatories requested approval of a modification of their *Unanimous Stipulation and Agreement* approved in File No. ET-2020-0022 on June 27, 2020, and for Commission approval of a revised tariff sheet.

The revisions will extend the deadline for refunds of Ameren Missouri's Community Solar Participation Fees from March 31, 2022 to June 30, 2022. The Signatories explained that manufacturer delays as a result of the COVID-19 pandemic have delayed the Montgomery County Community Solar Energy Center coming into service.

The Commission will set a time for responses to the motion and tariff.

THE COMMISSION ORDERS THAT:

1. Any responses or objections to the motion or revised tariff sheet shall be filed no later than February 7, 2022.

2. This order is effective when issued.
