On August 24, 2022, Grain Belt Express LLC filed an application seeking an order amending its certificate of convenience and necessity granted in File No. EA-2016-0358. Paragraph 95 of the application refers to Schedule AB-3 of the Direct Testimony of Andrew Burke (a legal description of the proposed route for the Tiger Connector) and Paragraph 96 refers to Schedule AB-4 of the Direct Testimony of Andrew Burke (a list of all utilities, railroad tracks, and underground facilities that the proposed Tiger Connector will cross). Additionally, the Direct Testimony of Kevin Chandler, filed simultaneously with the application, references Schedule KC-5 (Missouri Landowner Protocol Clean & Redline). Schedules AB-3, AB-4, and KC-5 are not attached to the testimony. The Commission will direct Grain Belt Express to file the omitted schedules.

THE COMMISSION ORDERS THAT:

1. No later than September 1, 2022, Grain Belt Express shall file Schedules AB-3, AB-4, and KC-5.
2. This order shall be effective when issued.
