

**ORDER GRANTING LATE INTERVENTION**

On May 30, 2000, ExOp of Missouri, (ExOp), filed its Motion to Intervene out of Time. ExOp states that at the time for filing to intervene it believed that its interests would be similar to interests of other parties and would be represented. Subsequently, through discussions with the Commission's Staff and with other parties, ExOp has determined that its service offerings will be more directly impacted than it believed previously.

ExOp states that it believes that granting it intervention under 4 CSR 240.075(4)(D) is supported by good cause in that intervention would allow it to protect its interests and allow for more full presentation of the varying interests of telecommunications providers in the State of Missouri on the issues presented in this case. No objections to this late intervention have been filed.

The Commission finds that good cause exists to grant the Motion to Intervene Out of Time.

**IT IS THEREFORE ORDERED:**

1. That the Motion to Intervene Out of Time filed by ExOp of Missouri is accepted and ExOp is granted intervention in accordance

with 4 CSR 240-2.075, and the Commission's Records Department shall add its attorneys to the service list in this case: Peter Mirakian III and Wendy DeBoer, 1000 Walnut Street, Suite 1400, Kansas City, Missouri 64106-2140.

2. That this order shall become effective on June 19, 2000.

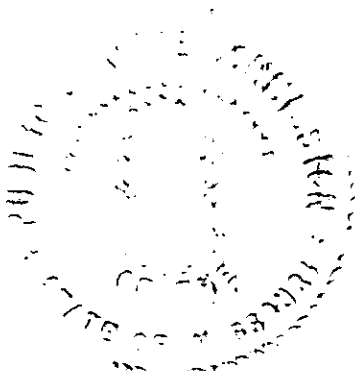
