**ORDER RECOGNIZING CHANGE OF CORPORATE
NAME AND APPROVING REVISED TARIFF**

On January 10, 2000, NYNEX Long Distance Company d/b/a Bell Atlantic Long Distance (NYNEX) submitted a replacement tariff with an effective date of February 10, 2000, designed to reflect that it has changed its corporate name from NYNEX Long Distance Company d/b/a Bell Atlantic Long Distance to NYNEX Long Distance Company d/b/a Bell Atlantic Business Services. NYNEX also filed a registration of a fictitious name and an amended certificate of authority of a foreign corporation, both issued by the Missouri Secretary of State, dated November 19, 1999, showing the new name, NYNEX Long Distance Company d/b/a Bell Atlantic Business Services.

The Staff of the Commission (Staff) filed a memorandum on January 20, 2000, stating that it had reviewed NYNEX's filings and revised tariff and had no objection to their approval. Staff recommended that the name change be recognized and the revised tariff be approved to become effective February 10, 2000.

The Commission has reviewed NYNEX's filings, the revised tariff, and Staff's recommendation, and finds that the change of name should be recognized. The Commission further finds that the revised tariff reflecting the change of name should be approved.

IT IS THEREFORE ORDERED:

1. That the change of name from NYNEX Long Distance Company d/b/a Bell Atlantic Long Distance to NYNEX Long Distance Company d/b/a Bell Atlantic Business Services is acknowledged.
2. That the revised tariff denominated Mo. P.S.C. No. 1 Original Pages 1 - 34 is approved to become effective on February 10, 2000.
3. That this order shall become effective on February 11, 2000.
4. That this case may be closed on February 12, 2000.

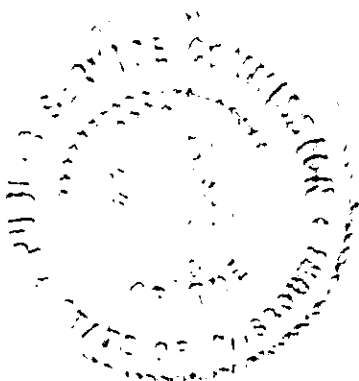
