ORDER APPROVING BTU ADJUSTMENT

On July 17, 1989, United Cities Gas Company of Brentwood, Tennessee, submitted to this Commission for approval, a tariff sheet reflecting a decrease in the Hannibal-Canton District's current BTU factor due to a recomputation per the Thermal Content of Gas Supplied Rider.

The Staff of the Missouri Public Service Commission (Staff) recommended the tariff be approved interim subject to refund to allow Staff time to determine the impact of the Commission's Report And Order in Case No. GR-88-31. Staff has reviewed the Report and Order in Case No. GR-88-31 and is of the opinion that the interim subject to refund condition is no longer necessary. Therefore, Staff recommends P.S.C. MO. No. 2 1st Revised Sheet No. 14.1 no longer be interim subject to refund.

The Commission has reviewed this matter and, based upon Staff's recommendation, the Commission has determined that P.S.C. MO No. 2 1st Revised Sheet No. 14.1 should no longer be interim subject to refund.

On January 18, 1990, Company submitted to this Commission for approval, a tariff sheet reflecting a decrease in the Hannibal-Canton District's current BTU factor due to a recomputation per the Thermal Content of Gas Supplied Rider. The newly-computed factor is 1.019 therms per 100 cubic feet. This is a decrease of 0.002 therms per 100 cubic feet from the previous factor. Staff recommended the tariff be approved.

Based on Staff's recommendation and for good cause shown pursuant to Section 393.140(11) RSMo 1986, the Commission is of the opinion that the proposed tariff sheet should be allowed to go into effect on the requested effective date, February 1, 1990.

ORDERED: 1. That the BTU factor reflected in P.S.C. MO. No. 2 1st Revised Sheet No. 14.1 is no longer interim subject to refund.




