ORDER APPROVING TARIFF PURSUANT TO COMMISSION ORDER

On July 3, 1996, the Commission issued its order approving a stipulation and agreement. As part of that order, the Commission approved proposed tariffs, to be filed for service on or after July 9, 1996. Schedule QF, specifying the qualifying facilities rate schedule, was part of the proposed tariffs approved by the Commission as part of the stipulation and agreement. Kansas City Power and Light Company (KCPL) inadvertently omitted the QF tariff from its original tariff filing for service on or after July 9, 1996.

On November 20, 1996, KCPL submitted the QF tariff, with an effective date of December 21, 1996. On December 3, 1996, the Staff of the Commission (Staff) filed its recommendation, explaining that the QF tariff had been inadvertently omitted from the original filing and that KCPL currently has one customer on the tariff. This customer has been receiving service under the tariff since its original approval in October 1995. Approval of the instant tariff will, therefore, have no effect on either the customer or KCPL. The QF tariff remains almost identical except for language indicating that the QF rate is temporary pending the outcome of Case No. ET-97-113. The Staff has no objection to the tariff, as it was clearly inadvertently omitted from the original filing.

The Commission has reviewed the proposed tariff and Staff recommendation, and finds that the instant tariff was inadvertently omitted

from the original filing in Case No. EO-94-199, and that the tariff was initially approved for filing as a part of the Commission approval of the stipulation and agreement in that case. The Commission further finds the proposed tariff to be reasonable and in compliance with the Commission's order in that case and will, therefore, approve the QF tariff for service on or after December 21, 1996.

IT IS THEREFORE ORDERED:

1. That the following tariff, filed November 20, 1996, by Kansas City Power and Light, is hereby approved for service on or after December 21, 1996:

2. That this order shall become effective on December 21, 1996.
