ORDER APPROVING TARIFF

On November 9, 1989, Bowling Green Gas Company (Company) of Bowling Green, Missouri, submitted to this Commission for approval, a tariff which reflected a change in rates as a result of the recalculation of the Company's Actual Cost Adjustment (ACA) factor. The tariff was approved to become effective November 21, 1989, interim subject to refund in order to allow Staff additional time to complete its review of the ACA filing.

On March 30, 1990, Staff submitted a memorandum to Case No. GR-90-99 indicating the audit of Company's 1988-1989 ACA filing was completed. Several adjustments were recommended in that memorandum. The net effect of those adjustments was the proposed return of an additional \$5,181 in overcollections.

On April 9, 1990, Company submitted for Commission approval a tariff which reflects a revised ACA factor designed to refund the additional \$5,181. The tariff has a proposed effective date of April 23, 1990. Staff recommends the tariff be approved. Staff further recommends that the tariff submitted by Company November 9, 1989, no longer be interim subject to refund.

After reviewing Staff's recommendations and for good cause shown pursuant to Section 393.140(11) RSMo 1986, the Commission is of the opinion that the proposed tariff sheet should be allowed to go into effect on the requested effective date, April 23, 1990. The Commission is also of the opinion that the tariff submitted November 9, 1989, shall no longer be interim subject to refund.

It is, therefore,

ORDERED: 1. That the following tariff sheet submitted April 9, 1990, by Bowling Green Gas Company, of Bowling Green, Missouri, for the purpose of reflecting a change in the PGA factor as a result of an adjustment to the Actual Cost Adjustment factor be, and the same is, hereby authorized to become effective on April 23, 1990.
