ORDER APPROVING TARIFF

On October 5, 1994, Southwestern Bell Telephone Company (SWBT) filed this tariff to resolve tariffing complications developed from previously approved primary toll carrier changes between GTE, United and SWBT in Case No. TT-94-119. These complications arise from timing differences between the approval dates of tariffs due to an appeal of Case No. TC-93-224 and the resulting stay which was imposed on Case No. TT-94-119. The tariff filing herein attempts to resolve the administrative complications so that tariff page numbering and the overall tariff will accurately reflect the Commission's decision as ordered in Case No. TT-94-119.

The Staff Memorandum was filed on October 27, 1994. The Staff Memorandum recommends the Commission approve the tariff on an expedited basis as requested by SWBT. Staff has further stated in its recommendation that the filings reflect only administrative changes and do not accomplish any substantive change to the company's tariff. The tariff information filed by the company in this case states that approving this tariff will complete the rehomings which was approved in Case No. TT-94-119 but which had not yet been completed.

The Commission has reviewed the tariff filed by the company along with the Staff Memorandum and the entirety of the file and finds that the tariff filed herein will finally implement that which was ordered by the Commission in Cases No. TT-94-119 and TC-93-224. The Commission finds that this tariff filing is just and reasonable to implement the prior orders and will approve the tariff for service on and after October 29, 1994.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by Southwestern Bell Telephone Company on October 5, 1994, shall be approved for service on and after October 29, 1994.

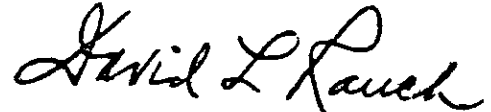
