ORDER APPROVING TARIFF SHEETS

QCC, Inc. submitted a proposed tariff sheet to the Public Service Commission on May 15, 1995, designed to introduce seven new services, change the rates for its operator services, and remove tariff language referring to Bulk Transmission services. QCC's tariff carried an effective date of June 5, 1995, which was later extended to June 15, 1995. QCC proposes to remove service and rate description text which refers to Bulk Transmission Services because this service is no longer being offered to Missouri customers. The tariff provides for increases in operator per-call charges and for an Operator Dialed (0-) surcharge. The tariff also describes the following new calling plans: 1) a "1+" direct dial business/residence service called MTS Service; 2) an intrastate outbound calling plan called One Plus Switched Service - Option I; 3) an intrastate calling plan available to customers with maintenance contracts called One Plus Switched Service - Option II; 4) a dedicated outbound calling plan for business customers called One Plus Dedicated Service; 5) a calling plan for residential and business subscribers called Switched 800 Service; 6) a travel card service; and 7) a debit card service.

The Staff of the Missouri Public Service Commission filed a memorandum on May 25, 1995, recommending approval of the tariff sheets filed. Staff stated that it had reviewed the proposed tariff sheets and had no objection to approval of the new services, the operator services rate changes, and removal of the Bulk Transmission Service language. Staff recommended that the proposed tariff sheets be approved.

Having reviewed the company's proposed tariff sheets and Staff's recommendation, the Commission finds that QCC's request to introduce the described services, change the rates for its operator services, and remove tariff language referring to Bulk Transmission services is reasonable. The Commission finds that the tariff sheets filed on May 15, 1995, are in the public interest and should be approved to be effective June 15, 1995.

IT IS THEREFORE ORDERED:

1. That the tariff submitted by QCC, Inc. on May 15, 1995, be approved for service on and after June 15, 1995. The tariff sheets approved are:
