ORDER APPROVING TARIFF SHEETS

On March 13, 1996, the Commission received proposed tariff sheets from AT&T Communications of the Southwest, Inc. (AT&T) designed to extend Promotions A and P for AT&T Software Defined Network Service and Promotion P for AT&T Virtual Telecommunications Network Service. These promotions would be extended through June 30, 1996. The proposed tariff sheets also reestablish Promotion A for AT&T Virtual Telecommunications Network Service through June 30, 1996. AT&T requested the proposed tariff sheets be approved with less than 30 days notice. This case was established to consider that request.

Staff filed a memorandum on March 29, 1996, recommending approval of the tariff sheets. Staff indicates these promotions have been approved previously.

The Commission has reviewed the proposed tariff sheets and finds that they should be approved. The promotions are for competitive services for which the Commission has determined that the market should determine if the promotion is fair. The Commission will also approve the tariff sheets on less than 30 days notice as requested. This expedited treatment will ensure there is little disruption of a customer's service.

IT IS THEREFORE ORDERED:

1. That the proposed tariff sheets received from AT&T Communications of the Southwest, Inc., on March 13, 1996, are hereby approved for service on and after April 4, 1996. The tariff sheets approved are:
