ORDER APPROVING TARIFFS

Tariffs have been filed by Missouri local exchange telephone companies to implement the Link Up Missouri connection assistance program. The Missouri legislature recently passed legislation which authorized the Commission to approve tariffs for Link Up Missouri. The tariffs have 30-day effective dates but the telephone companies request the tariffs be approved on less than 30 days notice to allow the tariffs to go into effect on or before a public announcement of the program on September 26, 1988.

Forty-six telecommunications companies have filed tariffs to implement the program. The companies are:

On September 15, 1988, Commission Staff filed a memorandum concerning the tariffs. Staff states in its memorandum that all local exchange telephone companies in Missouri are proposing to either establish or revise Link Up Missouri tariffs. Link Up Missouri is a federally funded service connection program designed to reduce service connection charges by 50 percent, up to a maximum of \$30.00, for eligible subscribers. Staff indicates all local exchange companies have filed tariffs to implement Link Up Missouri. The companies and those tariffs are listed on Appendix A attached to this order.

Based upon the tariffs filed by the local exchange companies and Staff's recommendation, the Commission has determined that the tariffs should be approved. The Commission has determined there is good cause to approve the tariffs on less than 30 days notice.

It is, therefore,

ORDERED: 1. That the tariffs as set out in Appendix A are approved to become effective on September 26, 1988.

ORDERED: 2. That there is good cause to allow the tariffs to go into effect on less than thirty (30) days notice.

ORDERED: 3. That this order shall become effective on the 26th day of September, 1988.
