On Wednesday, January 6, 2010, the Missouri Public Service Commission voted to send the proposed RES rules to the Missouri Secretary of State for publication in the Missouri Register. It is anticipated that the publication date would be February 16, 2010. I have attached a link to the new Case Number (EX-2010-0169) in the PSC electronic filing system. Item 1 is the notice for opening the case, Items 2 & 3 are the proposed rules, and Item 4 is the notice for the Public Hearing. The Public Hearing is scheduled for 9:00 a.m., Tuesday, April 6, 2010 in Room 310 of the Governor Office Building, Jefferson City, MO.
