ORDER APPROVING TARIFF SHEETS

By its Order issued in these cases on May 19, 1987, this  
Commission approved and adopted the Stipulation and Agreement wherein  
Alltel Missouri, Inc. was authorized to decrease Missouri jurisdictional  
gross annual revenues by \$800,000 effective June 1, 1987.

In conformance with the Order of the Commission, Alltel  
Missouri, Inc., on May 21, 1987, submitted for Commission approval,  
revised tariff sheets containing rates designed to decrease annual  
revenues by approximately \$800,050, exclusive of license, occupation,  
franchise, sales, gross receipts or other similar fees or taxes, with a  
requested effective date of June 1, 1987.

The Commission is of the opinion the proposed tariff sheets  
comply with the Order issued May 19, 1987, and said tariff sheets should  
be allowed to become effective June 1, 1987.

It is, therefore,

ORDERED: 1. That the following tariff sheets submitted by  
Alltel Missouri, Inc., containing rates designed to decrease Missouri  
jurisdictional gross annual revenues by approximately \$800,000 be, and  
the same are, hereby approved for telephone service rendered on and after  
June 1, 1987.


