#### ORDER APPROVING STIPULATION AND AGREEMENT

On November 8, 1988, a Stipulation and Agreement was executed by Citizens Telephone Company of Higginsville, Missouri and the Staff of the Missouri Public Service Commission. The Stipulation involves a reduction to the Company's monthly local access rates by \$2.00 per line, a reduction of approximately \$80,000 on an annual basis.

The Stipulation adequately sets forth all procedural and factual matters and is set forth in Appendix A attached hereto and incorporated herein by reference.

Citizens Telephone Company of Higginsville, Missouri, is a public utility subject to the jurisdiction of this Commission pursuant to Chapters 386 and 392, RSMo 1987, Supp. For ratemaking purposes the Commission may accept a Stipulation and Agreement in settlement of any matters submitted by the parties. The Commission is of the opinion that the matters of agreement between the parties in this case are reasonable and proper and should be accepted.

It is, therefore,

ORDERED: 1. That the Stipulation and Agreement filed herein on November 8, 1988, be, and it is, hereby approved.

ORDERED: 2. That Citizens Telephone Company of Higginsville, Missouri, is hereby authorized to file revised tariffs designed to reduce its monthly local access rates by \$2.00 per line, a reduction of approximately \$80,000 on an annual basis. The tariffs shall bear an effective date of December 1, 1988.

ORDERED: 3. That Citizens Telephone Company of Higginsville, Nissouri, shall not be subject to any further requirements from Case No. A0-87-48 and is hereby dismissed as a party from that proceeding.

ORDERED: 4. That this Order shall become effective on December 1, 1988.

## STIPULATION AND AGREEMENT

September 16, 1988, Citizens Telephone Company On of Higginsville, Missouri (Company) filed a financing application with the Missouri Public Service Commission (Commission) in Case No. TF-89-60. During its review in that case, it appeared to the Commission Staff that Company was experiencing earnings in excess of what might otherwise be a reasonable level of earnings given current circumstances. Representatives of the Commission Staff and Company engaged in discussions concerning the impact of the Federal Tax Reform Act of 1986 on Company's revenue requirements. As a result of these discussions, the parties stipulate and agree as follows:

 That Company shall file tariffs, effective December 1, 1988, which will reduce its monthly local access rates by \$2 per line; the reduction will approximate \$80,000 annually;

2. That this Stipulation and Agreement is a negotiated settlement which is intended to dispose of decreases in Company's gross annual revenue requirement for its Missouri jurisdictional operations due to provisions of the Federal Tax Reform Act of 1986. In addition, Company shall not be further subject to any present or future requirements of the instant docket; it being understood, however, that neither Commission Staff nor any other party is bound in any proceeding other than the above-captioned docket regarding the effects of the Tax Reform Act on Company's revenue requirement;

3. That this Stipulation and Agreement is intended to be binding on the parties and the Commission for purposes of Commission Case No. AC-87-48 (as it relates to Company); that none of the provisions of this Stipulation and Agreement, however, shall prejudice, bind, or otherwise affect any party should the Commission decide not to approve this Stipulation and Agreement in its entirety or in any way condition its approval of same;

MINUS SERVICE ODIANISSION

4. That except as otherwise expressly provided herein, the parties to this Stipulation and Agreement shall not be deemed to have approved of or acquiesced in any expressed or implied ratemaking principle, valuation method, cost of service method, or rate design proposal;

5. That in the event the Commission accepts the specific terms of this Stipulation and Agreement, the parties waive their respective rights to present oral arguments or written briefs, pursuant to Section 536.080(1), RSMo 1986 and their respective rights to judicial review regarding the dispositions of these matters, pursuant to Section 386,510, RSMo 1986;

6. That the agreements contained in this Stipulation and Agreement have resulted from extensive negotiations among the signatory parties and are interdependent; that in the event the Commission does not approve and adopt the terms of this Stipulation and Agreement and in the event the tariffs agreed to herein do not become effective in accordance with the provisions contained herein, this Stipulation and Agreement shall become effective in accordance with the provisions contained herein, this Stipulation and Agreement shall be void and no party shall be bourd by any of the agreements or provisions hereof.
