ORDER APPROVING TARIFF FILED IN COMPLIANCE WITH COMMISSION ORDER

On August 31, 2000, the Commission issued a Report and Order approving a written territorial agreement between Union Electric Company d/b/a AmerenUE (AmerenUE) and Intercounty Electric Cooperative Association. On October 10, AmerenUE filed revised tariff sheets reflecting the changes to AmerenUE's service area resulting from the territorial agreement. AmerenUE's tariff sheets bore an effective date of November 9.

The Staff of the Commission (Staff) reviewed the tariff sheets and filed a Recommendation and Memorandum on October 17, indicating that the submitted tariff sheets were timely filed and are in compliance with the Commission's order of August 31. Staff recommends that the Commission approve the submitted tariff sheets, effective on November 9, the requested effective date.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets conform to the Commission's order of August 31 and should be approved to become effective on November 9.
