- 1. FirstWorld, a subsidiary of Verado Holdings, Inc., is a certificated interexchange carrier in Missouri with its principal place of business located at 8390 E. Crescent Parkway, Suite 300, Greenwood Village, Colorado 80111. FirstWorld Communications, Inc., a Delaware corporation, was authorized on December 10, 1998, in Case No. TA-99-190, to offer, render, furnish or supply interexchange telecommunication services as a reseller to the public within the state of Missouri. FirstWorld's Certificate to Transact Business as a Foreign Corporation was filed in that docket and is incorporated herein by reference.
- 2. Due to a change in business plans, FirstWorld requests the Commission to cancel its Certificate of Service Authority and Tariffs since FirstWorld has no customers in the state of Missouri and no longer provides telecommunications services in the state of Missouri.
