APPLICATION OF FRONTIER COMMUNICATIONS OF THE WEST, INC. TO CANCEL ITS CERTIFICATE OF SERVICE AUTHORITY

COMES NOW Frontier Communications of the West, Inc. (formerly West Coast Telecommunications, Inc.) ("Applicant"), by and through its attorneys and pursuant to 4 CSR 240-2.060(1), respectfully requests the Missouri Public Service Commission ("Commission") to Cancel its Certificate of Service Authority. In support of its Application, Frontier Communications of the West, Inc. states as follows:

- 1. Applicant is a certificated interexchange in Missouri with its principal place of business located at 180 South Clinton Avenue, Rochester, New York 14646. Applicant was granted a Certificate of Service Authority in Case No. TA-94-52 on December 21, 1993 as West Coast Telecommunications, Inc. On July 10, 1996, West Coast Telecommunications, Inc. filed notice with the Commission that the company changed its name to Frontier Communications of the West, Inc. in Docket Number TO-97-12. The company's Certificate to Transact Business as a Foreign Corporation was filed in both dockets and were incorporated by reference.
- 2. The Applicant has not provided any retail telecommunications services in Missouri since mid-1998. Accordingly, the Applicant requests the Commission to cancel its Certificate of Service Authority and its tariff prior to December 31, 2000.

- 4. Applicant has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the Application.
- 5. Applicant has recently filed its Annual Report with the Commission and no assessment fees are overdue.

WHEREFORE, Frontier Communications of the West, Inc. respectfully requests the Commission to grant its Application to Cancel Certificate of Service Authority, and for any other relief appropriate in the circumstances.
