

On March 9, 2001, the Staff of the Missouri Public Service Commission (Staff) filed a Motion to Correct Record, stating that the official case file maintained by the Commission's Records Department does not include the correct version of the HC report entitled *Hawthorn 5 February 17, 1999, Boiler Explosion Investigation Report* prepared by Kansas City Power & Light Company (KCPL). Staff further stated that it had contacted the other parties to this case and that none of them objected to Staff's correcting the official record. No party has filed objections to Staff's motion and the time for doing so has passed. Therefore, the Commission will grant Staff's motion and correct the record.

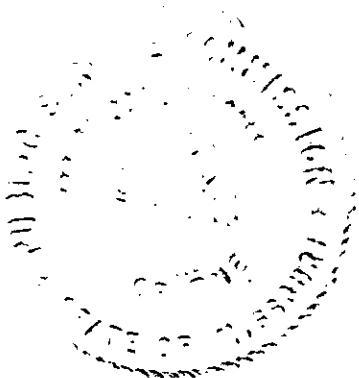
