ORDER DIRECTING FILING

On December 11, 2000, the parties herein unanimously moved the Commission to cancel the Prehearing Conference set for December 20, 2000, to relieve the parties of the obligation to file a joint Proposed Procedural Schedule by December 27, 2000, and to hold this case in abeyance pending final judicial resolution of certain similar issues presented by other cases.

Inasmuch as the resolution of this case will necessarily turn on the judicial resolution of the issues now on review in other cases, the Commission will hold this case in abeyance pending notification by the parties that it is appropriate to activate this case and move it to resolution.


IT IS THEREFORE ORDERED:

1. That the prehearing conference previously scheduled in this matter for December 20, 2000, is canceled.
2. That the joint proposed procedural schedule, previously ordered for December 27, 2000, need not be filed.
3. That the parties shall file a pleading in this case advising the Commission of the final judicial resolution of Case No. GR-96-450 and that it is appropriate to reactivate this case and move toward its

resolution. A copy of the final judicial determination of Case No. GR-96-450 shall be attached to the pleading herein described.

4. That this order shall become effective on December 20, 2000.
