

**ORDER AND NOTICE**

On February 6, 1997, Kansas City Power & Light Company (KCPL or Applicant), filed an application with the Commission requesting authority to sell to the City of Kansas City, Missouri certain streetlighting facilities subject to the jurisdiction of the Commission. Applicant is a Missouri corporation, with its principal office and place of business located at 1201 Walnut, Kansas City, Missouri 64106. On February 26, 1997 KCPL filed an amended application. Along with its application KCPL also filed a description of the streetlighting system to be sold, listed as Appendix 1. In the amended application a copy of the resolution by KCPL's Board of Directors authorizing the sale of the streetlighting facilities to the City, along with a copy of the streetlight sale agreement was included as Appendix 3.

*In its application KCPL states that it is presently engaged principally in the generation, transmission, distribution and sale of electric energy. In its application KCPL states that the proposed sale of the streetlighting system will not be detrimental to the public interest. The City's own evaluations indicate that this transaction is more economically advantageous in the long term than the current leasing arrangement.*

The Commission finds that Notice of this application should be given by the Records Department of the Commission by transmitting a copy of this order to the County Commission of each of the counties served by KCPL. In addition, the Information Officer of the Commission shall provide notice to the Members of the General Assembly representing counties served by KCPL, to all publications of general circulation in the Missouri service area of Kansas City Power and Light, and to the Mayor of Kansas City, Missouri.

The Commission also determines that proper persons shall be given the opportunity to intervene in this case. Applications to intervene shall be filed with the Executive Secretary of the Missouri Public Service Commission, P.O. Box 360, Jefferson City, Missouri 65102, on or before April 3, 1997. Copies of applications to intervene should be sent to Susan B. Cunningham, Staff Attorney, Kansas City Power & Light Company, P. O. Box 418679, Kansas City, MO 64141-9679.

In the event no proper person files an application to intervene in this matter, the Commission may allow Applicant to submit evidence by its verified application and attachments.

**IT IS THEREFORE ORDERED:**

1. That the Records Department of the Missouri Public Service Commission is ordered to serve notice as set out herein.
2. That the Information Officer of the Missouri Public Service Commission is ordered to serve notice as set out herein.
3. That any proper person wishing to intervene in this matter shall file an application to do so no later than April 3, 1997. Applications to intervene shall be filed with the Executive Secretary of the Missouri Public Service Commission, P.O. Box 360, Jefferson City, Missouri 65102, and a copy served on Susan B. Cunningham, Staff Attorney,

Kansas City Power & Light Company, P. O. Box 418679, Kansas City, MO 64141-9679.

4. That this order shall become effective on the date hereof.
