

## ORDER ESTABLISHING ACA BALANCE AND CLOSING CASE

The Commission issued an Order Directing Response on July 12, 2000, directing Fidelity to respond to Staff's recommendation by August 24, 2000. Fidelity filed a response on August 7, 2000, wherein it stated: "Staff's recommendations are acceptable to the Company and should be implemented. Fidelity will also supply the analysis in future ACA periods, as requested by the Commission Staff."

The Commission has reviewed the memorandum filed by Staff and the response filed by Fidelity. The Commission determines that the ending balances shown in the Staff recommendation are reasonable and should be approved. The Commission further determines that this case should be closed.

**IT IS THEREFORE ORDERED:**

1. That Fidelity Natural Gas, Inc., shall establish the Actual Cost Adjustment account balances in its next Actual Cost Adjustment filing as discussed herein.
2. That this order shall become effective on September 1, 2000.
3. That this case may be closed on September 5, 2000.
