**ORDER CANCELING HEARING AND
DIRECTING FILING OF PROCEDURAL SCHEDULE
OR STIPULATION AND AGREEMENT**



On July 30, 2001, the Director of the Division of Manufactured Homes and Modular Units of the Missouri Public Service Commission filed with the Missouri Public Service Commission a parties' statement of settlement.

The pleading stated:

1. On May 15, 2001, the Commission set an evidentiary hearing for July 31, 2001;
2. However, the Director and Discount have reached a mutually agreeable settlement of the case that makes an evidentiary hearing unnecessary. Therefore, the Director and Discount would request that the hearing be canceled. The Office of the Public Counsel does not object to this request; and

3. The Director and Discount will file a formal Stipulation and Agreement on or before August 14, 2001.

The Commission will cancel the evidentiary hearing set for July 31, 2001. The Commission will also set a date for the filing of a proposed procedural schedule or the stipulation and agreement promised by the parties.

IT IS THEREFORE ORDERED:

1. That the evidentiary hearing set for July 31, 2001, is canceled.
2. That a procedural schedule or the stipulation and agreement of the parties must be filed no later than August 14, 2001.
3. That this order will become effective on July 31, 2001.


